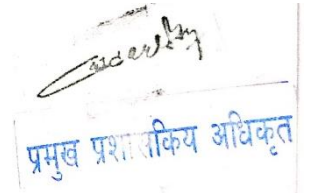

- Electronic bids must be submitted to the office **Kumakh Rural Municipality** through PPMO website **www.bolpatra.gov.np/egp** on or before 12:00 Noon **2077/08/25** (10-12-2020). Bids received after this deadline will be rejected.
- The bids will be opened in the presence of Bidder's representatives who choose to attend at 14:00 Hrs on **2077/08/25** (10-12-2020) at the Kumakh Rural Municipality Office, Salyan. Bids must be valid for a period of **90 days** and must be accompanied by a scanned copy of the bid security in pdf format, amounting to a minimum of above bid security, which shall be valid for **30 days** beyond the validity period of bid.
- If the last date of purchasing or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
